The deadline date for submission of vetting applications in accordance with Section 21 of the National Vetting Bureau (Children and Vulnerable Persons) Acts 2012 to 2016 (Retrospective Vetting) has been changed from the 31st December 2017 to the 30th April 2018.

To clarify, a new deadline of the 30th April 2018 has been given by the Department of Justice and Equality for the submission of Retrospective Vetting Applications for all relevant organisations.
